- Your name and address.
- Parents names and address/addresses
- A personal letter describing your college plans, telling why you believe you deserve this scholarship.
- List of school activities (community activities, honors and awards, other scholarships received).
- Official transcript of grades, and ACT or SAT scores.
- Letter of acceptance from an accredited college or university, if possible.
- Three letters of recommendation , two from school teachers or administrators, and one from a community member.

The completed application, including references, should be returned to the appropriate office at the high school.
